The concentrated, alkali-free **Handwashing Paste** for the removal of medium to heavy soiling.

PROPERTIES

PEVAPURA removes medium to heavy soiling such as oil, grease, tar, bitumen, various types of paints, printing inks, etc.

- ✓ cleanses thoroughly and is gentle to the skin.
- ✓ is a non-flowable paste and therefore not suitable for dispensing systems.
- ✓ is extremely versatile and can be used in many areas of industry, the trades, agriculture, horticulture, etc.

COMPOSITION

PEVAPURA consists of selected, high-quality raw materials, which are to a large extent of plant origin.

- contains a synergistic surfactant system, which ensures the skin-friendly removal of soilings.
- contains finely ground wood flour as a natural abrasive. The use of wood flour abrasive does not contribute to tree felling since sawdust from joineries is used as a raw material. The sawdust is processed and finely ground.
- wood flour abrasives do not clog any drains.
- is pH-neutral to skin.
- is silicon-free.
- is dermatologically tested with the rating „very good“.

APPLICATION

Rub **PEVAPURA** into dirty, dry hands until the dirt dissolves. Add some water, wash thoroughly and rinse well.

Note: Avoid contact with eyes. If it comes to contact with eyes, flush with large amounts of water.

PRODUCT DESCRIPTION

PEVAPURA is a beige, non-flowable paste.

pH-value: approx. 5,4 - 5,8

Density: approx. 0,8 g/cm³ (20°C)

LEGAL REGULATIONS

PEVAPURA is subject to the EU Cosmetics Regulation and in Germany to the Food, Consumer Goods and Feed Code (LFGB).

All our cosmetic products are manufactured according to GMP (Good Manufacturing Practice) and undergo microbial quality control.

STORAGE INSTRUCTIONS

PEVAPURA can be stored in closed original containers at room temperature for at least 24 months.

SKIN CARE TIPS

In the unavoidable handling of harmful substances, a suitable skin protection agent should be used to prevent skin damage before starting work (e. g. the generally applicable skin protection lotion **PEVAPERM**).

After work, the skin should be regularly rubbed with a suitable skin care product (e. g. **PEVALIND**, the active substance-rich skin care lotion) to regenerate the skin.
