## PROPERTIES

**PEVAPLUS PURE** is a perfume-free, environmental-ly friendly Cleansing Lotion for the removal of light soiling, e.g. in offices and administration, light storage and packaging activities, etc.

- is pH-neutral to skin.
- is silicone-free.
- is unscented.
- dermatologically tested with a rating of „very good“.

## APPLICATION

Apply **PEVAPLUS PURE** to moist skin and rub in. Then rinse off with water and dry.

*Note: Avoid contact with eyes. In the event of contact with the eyes, rinse immediately with plenty of water.*

**PEVAPLUS PURE** is a pearlescent, slightly viscous lotion, unscented.

## STORAGE INSTRUCTIONS

**PEVAPLUS PURE** can be stored in closed original containers at room temperature for at least 24 months.

## SKIN CARE TIPS

In case of exposure to harmful substances, an appropriate skin protection product should be used before work to prevent skin damage (e.g. the generally applicable skin protection lotion **PEVAPERM PURE**).

After work, the skin should be regularly rubbed with a suitable skin care product (e. g. **PEVALIND PURE**, the active substance-rich skin care lotion) to regenerate the skin.
