PROPERTIES

PEVASAN PURE is a particularly mild Skin Cleansing Lotion for the removal of light soiling, e.g. in offices and administration, in medical departments and care facilities, in the food processing industry, for light storage and packaging activities.

- ✓ is very skin-friendly due to a high proportion of moisturising substances
- ✓ can be applied to the entire body and can also be used for washing hair
- ✓ is HACCP-rated and can therefore be used within the framework of an HACCP concept in the food industry

COMPOSITION

PEVASAN PURE consists of selected, high-quality raw materials, which are to a large extent of plant origin.

- contains a complex, synergistic surfactant system, with so-called sugar surfactants, which ensures the skin-friendly removal of dirt
- contains a high proportion of a balanced refatting system, which counteracts degreasing of the skin with glycerine derivatives and skin-related care substances, especially for frequent washing
- is a colour neutral, pearlescent skin cleanser

- is pH-neutral to skin
- is unscented
- is silicon-free
- was rated „very good“ in a dermatological-allergological test on subjects with sensitive skin.

APPLICATION

Apply **PEVASAN PURE** to moist skin or hair and rub in. Then rinse with water and dry.

Note: Avoid contact with the eyes. In case of contact with eyes, rinse immediately with plenty of water

PRODUCT DESCRIPTION

PEVASAN PURE is a pearlescent, slightly viscous Skin Cleansing Lotion, unscented.

pH value: 5.0 – 5.8

Density: approx. 1,04 g/cm³ (20 °C)

LEGAL REGULATIONS

PEVASAN PURE is subject to the EU Cosmetics Regulation and in Germany to the Food, Consumer Goods and Feed Code (LFGB).

All our cosmetic products are manufactured according to GMP (Good Manufacturing Practice) and undergo microbial quality control.

STORAGE INFORMATION

PEVASAN PURE can be stored in closed original containers at room temperature for at least 24 months.

SKIN CARE TIPS

In the unavoidable handling of harmful substances, a suitable skin protection product should be used to prevent skin damage before starting work (e.g. **PEVAPERM**, the generally applicable Skin Protection Lotion).

After work, the skin should be regularly rubbed with a suitable skin care product (e.g. **PEVALIND**, the active substance-rich Skin Care Lotion) to regenerate the skin.
