





PEVA INSECT SPRAY

Skin protection spray to repel biting insects (e.g. domestic and tropical mosquitoes, horseflies) and ticks. Skin- and material friendly.

PROPERTIES

PEVA INSECT SPRAY provides effective skin protection against stinging insects (e.g. native and tropical mosquitoes, horseflies, etc.) for up to 8 hours and against ticks for up to 5 hours.

- the active ingredients in the product have been used for many years and are renowned for their high level of tolerance and effectiveness (icaridin)
- ✓ is a pleasantly naturally scented spray that is easy to apply and distribute over the skin
- is material-friendly; e.g. it does not damage clothing or shoes

COMPOSITION

PEVA INSECT SPRAY is an alcoholic-aqueous liquid with two different active ingredients.

- contains 20% icaridin; a highly effective, well-tolerated repellent that forms a perfumed film on the skin and thus repels mosquitoes, other biting insects and ticks
- contains 0.3% EC oil as an additional active ingredient, which is obtained from the leaves of the lemon eucalyptus and is then processed. EC oil boosts the effect of icaridin. The active ingredient also gives the product its pleasant, natural fragrance
- free from artificial colouring
- is unscented
- is silicone-free

APPLICATION

Spray **PEVA INSECT** SPRAY evenly onto all the areas of the skin to be protected at a distance of 15-20 cm and then massage in thoroughly. Recommendation: When using on the face, spray into the palm of your hand and apply sparingly over the face, avoiding the eye and mouth area.

Immediate active protection. Heavy perspiration may reduce the effective period of the spray. In this case, spray again to maintain maximum effectiveness. If used with sunscreen, apply the sunscreen 30 minutes before using **PEVA INSECT** SPRAY. Do not use on children under 2 years of age.

PRODUCT DESCRIPTION

PEVA INSECT SPRAY is an alcoholic-aqueous solution. pH value: 5-8 Density: approx. 0.97 g/cm³ (20°C)





STORAGE INSTRUCTIONS

PEVA INSECT SPRAY can be stored in closed original containers at room temperature for at least 36 months.

LEGAL REGULATIONS

PEVA INSECT SPRAY is subject to the Biocidal Products Regulation 528/2012. BAuA-Reg-No.: N- 113476. The product is labeled according to EU CLP Regulation 1272/2008.

A safety data sheet is available and must be taken into account. Use biocidal products with care. Always read the label and product information before use.

SKINCARE TIPS

If the skin at work is exposed to uv-rays from sunlight or technical radiation sources, it should be protected with a suitable skin protection product with high SPF (e.g. with the water resistant UV-Protection Lotion **PEVASUN UV50+**).

Depending on the type of soiling, an adapted hand cleaning agent should be used (e.g. **PEVASTAR** SOFT for medium to heavy soiling or the special Hand-Cleaning Wipes **PEVALIN WIPES** for extreme soiling, when no water is available).

After work, the skin should be regularly rubbed with a suitable skin care product to regenerate the skin (e. g. **PEVALIND**, the active substance-rich skin care lotion).

FURTHER INFORMATION

When handling the product, please comply with the instructions in the safety data sheet in accordance with the Ordinance on Hazardous Substances.



Hazard warnings: flammable liquid and vapour. Causes serious eye irritation.

Safety instructions: Keep out of reach of children. Keep away from sources of heat, hot surfaces, sparks, naked flames and other sources of ignition. Do not smoke.

IN CASE OF CONTACT WITH THE EYES: Rinse carefully with water for several minutes. Remove contact lenses if worn. Rinse the eyes again. Store in a well-ventilated place. Keep cool. Keep container tightly sealed. Only use in well-ventilated areas; do not inhale the spray mist. If swallowed, seek medical advice and present the package and label. Dispose of the contents/container at a hazardous or special waste collection point.
