



## PEVALIN SPEZIAL

The concentrated hand cleaning cream contains shea butter to remove excessive soiling such as paint, glue, resins, etc.



### PROPERTIES

**PEVALIN SPEZIAL** effectively removes stubborn or strongly adhering soiling such as synthetic resin, nitro and printing inks, adhesives and sealing materials, oils, greases, tar, bitumen, PU foams, resins, etc.

- ✓ Contains a newly optimised, microplastic-free formulation with improved cleaning performance.
- ✓ Cleanses deep into the pores and is gentle to the skin.
- ✓ Is suitable for use in various industrial sectors.

### COMPOSITION

**PEVALIN SPEZIAL** consists of selected, high-quality raw materials.

- Contains ester oils, which ensure good cleaning of the product and are nevertheless gentle to the skin.
- Contains a re-fattening formula based on shea butter and components of coconut oil, which ensures that the skin feels good after washing.
- Contains a combination of finely ground corn cob meal and walnut shell meal. Walnut shells and threshed corn cobs are waste products, so there is no competition with food.
- These rubbing agents do not clog drains.
- Is pH-skin neutral
- Contains natural, cold-pressed orange oil and is slightly scented.

- Is silicone-free
- Dermatologically tested with a rating of „very good“.

### APPLICATION

Rub **PEVALIN SPEZIAL** without water into dirty, dry hands until the dirt is dissolved. Add a little water, continue washing and rinse well. Do not let it get on plastics.

**PEVALIN SPEZIAL** is economical in use. One dispenser dose is adequate for thorough hand cleaning.

*Note: Avoid contact with eyes. In the event of contact with the eyes, rinse immediately with plenty of water.*

## STORAGE INSTRUCTIONS

**PEVALIN SPEZIAL** can be stored in closed original containers at room temperature for at least 24 months. Protect from frost.

## SKIN CARE TIPS

In case of exposure to harmful substances, an appropriate skin protection product should be used before work to prevent skin damage (e.g. the generally applicable skin protection lotion **PEVAPERM**).

After work, the skin should be regularly rubbed with a suitable skin care product (e. g. **PEVALIND**, the active substance-rich skin care lotion) to regenerate the skin.
